Call To Order

Approval of Meeting Minutes

Treasurer's Report

- IRS 990 Form
 - Letter received from IRS indicating they need another 60 days to officially respond.

Director's Report

- Brenda reported that traffic to the library has increased with the re-opening.
- Applied for the recovery grant for PPE, air filters, and curriculum printing.
- FCL will be at the farmer's market starting 6/21 from 6-7pm; will be alongside Maxwell starting 6/28.
- Several summer programs are going on or starting up, including the storywalk at Baltimore Woods, outdoor story time, and the summer reading program (with Maxwell).
- The Board discussed mask requirements for the library, and staff will follow social distancing protocols and continue to use the language from the Department of Health.
- In June, the Board will discuss the option to open up fines again for unreturned books.
- Brenda reported positive staff interactions as the library continues to open.

Old Business

 - Personnel committee will not be necessary at this point in time.
- Update on FCL Audit/Financial Review
 - Mary reached out to two individuals for quotes for a financial review, and has not yet heard back from either one.
 - The Board is still aiming to complete this by the end of the year, and will reach out to some additional individuals for quotes.

New Business

- Engineering Report: Long-Range Facility Plan
 - Gary is working on getting two quotes from commercial home inspectors for helping with future long-range facility planning.
 - Mike mentioned a 2016 architect report of the building; Brenda will look to see if this is in a file.

Any Other Business for the Board

- The President of Maxwell Library's Board invited FCL Board to attend their meeting; Gary and Brenda attended on Wednesdays. Will look to work together with Maxwell for upcoming activities.
- The Board discussed the possibility of having a small reception to thank past board members at the second farmer's market (6/28).
